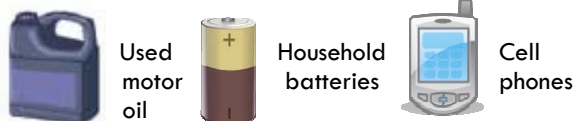

Curbside Service

To see if your waste hauler provides curbside pick-up for single family homes, check the chart on the reverse side.



***Note:** Used oil must be placed in a clear plastic container, taped shut to avoid spills, (limit: 2 gal.). Contaminated oil is not accepted. Put cell phones and batteries in a clear plastic zip-lock bag on top of your recycling container and use clear tape to cover the battery terminals. Contact your waste hauling company for further information and services.

Electronic Waste Disposal



Options for keeping your old computer, TV and other electronics out of the landfill include:

- Take-back programs from some manufacturers
- Take-back program from some retailers
- Donation to Goodwill – recyclers' job training program
- Collection events in your area

Sharps Disposal

Check with your health care provider to see if they offer free collection to their patients.

If your health care provider does not offer collection, find a disposal bin at the following locations:

- Willow Clinic –795 Willow Rd., Menlo Park
- San Mateo Medical Center –222 W.39th Ave
- San Mateo County Facility –32 Tower Rd, San Mateo

State law requires all syringes to be placed in an authorized sharps container. Do not dispose individual needles in drop-off containers.

Retail Take-Back

More and more stores that sell fluorescent lighting and household batteries will take them back, free of charge.

Hazardous Waste Disposal for Small Businesses

Small businesses that generate less than 100 kilograms (27 gallons or 220 pounds) of waste per month may be eligible to participate in the Very Small Quantity Generator (VSQG) Program.
