This letter and Annual Report Amendment is submitted by the City of South San Francisco pursuant to Permit Provision C.17.a of the Municipal Regional Stormwater NPDES Permit (MRP), Order R2-2015-0049, NPDES Permit No CAS612008 issued by the San Francisco Bay Regional Water Quality Control Board. The Annual Report provides documentation of compliance activities conducted during FY 2016/17 and related accomplishments.

This amendment consists of a revised Table 10-1 (Baseline trash generation and areas addressed by full capture systems and other control measures), as the original table contained a minor error pertaining to acreage reported in three (3) cells. The minor error was associated with the last minute changes that were made due to the additions of a few inlet-based FC devices that covered some on-land assessment sites that required inactivation. The reported percent trash reduction was correct, however, three acreage numbers in Appendix 10-1 were not updated prior to submitting the original report. For reference, a revised Table 10-1 as well as a comparison between the original and revised Table 10-1 are included with this amendment.
